Thank you for meeting last week to discuss the progress the State has made towards improving RI Bridges and the way in which we deliver health and human services to Rhode Island. As discussed, we are always looking to provide the Committee with data and updates that offer a comprehensive look at the health of the project. For this reason are changing the information we share with you and the cadence at which it is delivered.

As agreed upon, RI Bridges reports will now be submitted on a bi-weekly basis. Additional monthly updates will be shared every other submission. These additional monthly reports updates will include details about staffing and training plans at Department of Human Services (DHS), changes in State personnel involved in the project, an overview of system improvements and challenges and our monthly metrics dashboard.

This submission shares data from August 18 through August 27. Our next report will be provided to the Committee on September 15 and will include data from August 28 through September 10.
